

## PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to *Monthly Money Membership* and *North County Media* and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Monthly Money Membership include MonthlyMoneyMembership.com and MMM. The MMM website is a Monetary Sharing membership site. By using the MMM website, you consent to the data practices described in this statement.

### Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your debit or credit card or other payment information when ordering and purchasing our products or membership services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or or products you have requested from us including our membership service. We also may gather additional personal or non-personal information in the future. **Your membership details that you provide to Monthly Money Membership program will never be shared or sold to anyone.**

### Sharing Information with Third Parties

MMM does not sell, rent or lease its customer lists to third parties.

MMM may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to MMM, and they are required to maintain the confidentiality of your information.

MMM may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on MMM or the site; (b) protect and defend the rights or property of MMM; and/or (c) act under exigent circumstances to protect the personal safety of users of MMM, or the public.

### Automatically Collected Information

Information about your computer hardware and software may be automatically collected by MMM. This information can include: your IP address, browser type, domain names, access times and referring website address. This information is used for the operation of the service and membership, to maintain quality of the service, and to provide general statistics regarding use of the MMM website and nothing more. We take the utmost care in protecting your privacy.

## Security of your Personal Information

MMM secures your personal information from unauthorized access, use, or disclosure. MMM uses the following methods for this purpose:

- SSL (Secure Socket Layer) Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which is beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

## Safe & Secure *Stripe* and *BuyNowPlus* Payment Accounts

MMM and our members use *Stripe* and *BuyNowPlus* to Accept payments Safe & Secure with a complete payments platform infrastructure for the internet, engineered for growth. Millions of companies of all sizes—from startups to Fortune 500s—use *Stripe's* software and APIs to accept payments, send payouts, and manage their businesses online. **BuyNowPlus** acts as a Payment button which integrates with your *Stripe* account so everyone gets paid. ***Stripe handles your payment information, NOT Monthly Money Membership.*** For these reasons MMM will never know your private payment information.

## Right to Deletion

On Receipt of a verifiable request from you, email, phone call, we will delete your personal information from our records and direct any service providers to delete your personal information from their records. MMM has no control if any outside service will comply with our requests as it is solely up to that service provider after being notified to delete your records from their database.

Our payment provider (***Stripe***) and ***BUYNOWPLUS*** accounts may still have your records on file. It's your responsibility to make sure your account is closed with *Stripe* shall you decide to leave our Membership Community.

## **Children under Thirteen**

MMM does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must use this MMM website with a parent or guardians and with permission. PLUS the Parent or guardian must create an account with MMM so 13 and under can use this website along side with such parent or guardian. (*Example; this program may be used for fundraising and other community ideas.*) You must be 18 years of age to use our website without guardianship and to participate in our monthly membership program.

## **E-Mail Communication**

From time to time, MMM may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communications. ## **External Data Storage Sites**

We may store your website data on servers provided by third party hosting vendors with whom we have contracted, for instance any domain or hosting providers that store your username and/or passwords. We will NEVER share your private information.

## **Changes to this Statement**

MMM reserves the right to change this Privacy policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our website, and/or by updating any privacy information. Your continued use of the website and/or Services available after such modifications will constitute your: (a) acknowledgement of the modified Privacy Policy; and (b) agreement to the abide and be bound by that Policy.
